

# Bosch Easter Treat Giveaway

## Conditions of Participation and Entry

**1.** Below are the Conditions of Participation and Entry (**Conditions**) for the Bosch Easter Treat Giveaway (**Promotion**) including eligibility, age limits, exclusions, how to enter the Promotion and the Prize to be won. **2.** Participation in this Promotion constitutes acceptance of these Conditions. **3.** The **Promoter** means BSH Home Appliances Pty Ltd (ABN 22 109 198 405) (ACN 109 198 405) of 1555 Centre Road, Clayton, Victoria, Australia, 3168, telephone **1300 729 885**. **4. Eligibility:** Entry is only open to Australian residents with a residential address in Australia, aged 18 years or over at the date of entry with a public Instagram account (**Eligible Entrant**). Employees (and their immediate families) of the Promoter and agencies associated with this Promotion are ineligible to enter. Immediate family means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or first cousin. **5. Promotional Period** means the period commencing 18 March 2024 to 2 April 2024. **6.** Entries received after the Promotional Period will not enter the Promotion. **7. Instagram accounts must be public to enter. **8. Nature of the Promotion:** One winner will be selected by the judging panel, having regard to the relevance, skill, creativity and originality of the image on 8 April 2024. **9.** The judging panel will consist of representatives from the Promoter. **10.** Prize means one Bosch Unlimited 7 Rechargeable Vacuum Cleaner ProAnimal (BCS71PETAU). **11.** The total Prize is valued at \$699.00. **12.** Any other elements of the Prize including all other ancillary costs incurred as a result of taking the Prize, unless specified as included, are not included and remain the responsibility of the winner (as applicable). **13.** Prizes (or any element of a Prize), are not transferable, assignable or, exchangeable and cannot be taken as cash, cheque or electronic transfer. **14.** The Promoter accepts no responsibility for any variation in the value of the Prize beyond the Promoter's reasonable control. **15.** If the Prize (or element of the Prize) is unavailable, for reasons beyond the Promoter's reasonable control, the Promoter reserves the right to substitute the Prize (or that part of the Prize) with a prize of equal or greater value and / or specification, subject to any written directions from a regulatory authority. **16.** It is a condition of accepting the Prize that the winner must comply with all the conditions of use of the Prize and Prize supplier's requirements. Verification:** The Promoter reserves the right, at any time, to verify the validity of entries and Eligible Entrants (including an Eligible Entrant's identity, age and place of residence) and reserves the right, acting reasonably, to disqualify any individual who the Promoter has reason to believe has breached any of these Conditions, tampered with the entry process or, engaged in any unlawful or other improper misconduct calculated to jeopardise fair and proper conduct of the Promotion. Errors and omissions may be accepted at the Promoter's reasonable discretion. **30.** Incomplete or indecipherable entries will be deemed invalid. **31. Implied Guarantees:** Nothing in these Terms and Conditions limits, excludes or modifies or purports to limit, exclude or modify the statutory consumer guarantees as provided under the Competition and Consumer Act, as well as any other implied warranties under other applicable laws in the States and Territories of Australia where the Promotion is being conducted (**Non-Excludable Guarantees**). **32. The Privacy Policy also contains information about how Eligible Entrants may opt out, access, update or correct their PI, how Eligible Entrants may complain about a breach of the Australian Privacy Principles or any other applicable laws and how those complaints will be dealt with. Unless otherwise indicated by the Promoter, the Promoter may disclose PI to entities outside of Australia (for a list of the countries, see the Promoter's Privacy Policy) in accordance with applicable laws. **38.
