## **Bosch Series 8 oven, compact appliance and Induction cooktop Cashback Promotion Conditions of Entry**

This section sets out the Conditions for the Bosch Series 8 oven, compact appliance and induction cooktop Cashback (Promotion) and details how to claim your Bonus. **1. Definitions:** Bonus means \$200 for each Eligible Product purchased during the Promotion Period. **Eligible Product** means a Bosch HRG6767S2A, HBG6767S1A, HBG6753S1A, HBG675BS1B, HBG672BS1A, HBG655HS1A, HBG655HW1A, HBG633BS1A ovens, Bosch CSG656RS1A, CDG634BS1, CMG656RS1A, CMG633BS1B, CTL636ES1 compact appliances and Bosch PXV975DC1E, PXE875DC1E, PXX675DC1E, PIV995DC1E, PIV975DC1E, PVS875FB1E, PVS675FB1E, PIE631FB1E, PIJ611BB1E induction cooktops purchased from a participating Bosch reseller in Australia, excluding any Ineligible Product or Ineligible Purchases as defined in these Conditions. **Ineligible Product** means any project or commercial purchases, trade seconds, scratch and dent stock, ex-display or used stock. **Ineligible Purchases** means any lay-bys or similar arrangements (unless initiated and paid for in full during the Promotion Period), hire purchase or rental agreements and all purchases made directly from BSH Home Appliances Pty Ltd or from the Bosch Shop. **Promoter** means BSH Home Appliances Pty Ltd (ABN 22 109 198 405) of 1555 Centre Road, Clayton, Victoria 3168. **Promotion Period** means the period between 10 February 2017 and close of business on 16 April 2017 (inclusive). **2. Eligibility:** To be eligible to claim the Bonus, you must: **(a)** purchase an Eligible Product during the Promotion Period; and **(b)** be aged 18 years or over. Multiple claims permitted, subject to the following: **(a)** only one claim permitted per purchase of an Eligible Product i.e. one Bonus per Eligible Product; and **(b)** each claim must be submitted in accordance with the claim requirements specified in these Conditions. **3. Nature of Bonus:** The Bonus will not be paid by cash or cheque. The Purchaser will receive an eftpos gift card to the value of \$200 per eligible appliance. For example: if you purchase two eligible ovens or an eligible oven and compact receive \$400; if you purchase an eligible oven, a compact and an induction cooktop get \$600; if you purchase two eligible ovens, a compact and an induction cooktop receive \$800 etc. The bonus will be paid following completion of the online form found at [www.bosch-home.com.au](http://www.bosch-home.com.au) (online form) and compliance with the claim procedure. Please allow up to 60 days from the date that the claim is made to receive your gift card. The gift card must be activated within 60 days of being received. Gift cards will be valid for a 12 month period following activation and can be used at any eftpos terminal. Eftpos cards cannot be redeemed for cash, reloaded, returned for a refund, have their balances consolidated to a new gift card, or be replaced after expiry. BSH takes no responsibility for lost funds if the gift card is not activated in time or not used within 12 months from the activation date. **4. How to claim:** In order to obtain the Bonus, the online form must be completed in full, identifying the Purchaser's name, postal address, daytime contact

telephone number, email address, and the purchased Eligible Product's model and serial number. Claims must include a copy of the original invoice which clearly shows the Eligible Product(s) purchased and paid for in full within the Promotional Period (collectively **Claim Documents**). Claims will not be accepted by email, fax or any other means. **5. Proof of purchase is essential:** All claimants must retain their original invoice which clearly shows the Eligible Product(s) purchased. Claimants may be required to provide these invoices to the Promoter for ALL claims for verification purposes. Handwritten receipts and delivery dockets will not be accepted as proof of purchase. The Promoter reserves the right to request further information regarding proof of purchase from the claimant. Claims will be deemed invalid if the same invoice/receipt number or Eligible Product serial number is used for more than one claim. **6. Deadline:** Claim Documents must be received by the Promoter strictly by **30 June 2017**. Claims received after this date will not be processed and no Bonus will be issued. The Promoter accepts no liability for claims that are delayed, misdirected or lost in the mail. **7. Privacy:** The Promoter may collect personal information in order to administer the Promotion, the product warranty, for its own marketing purposes and for market analysis. The Promoter may for this purpose, disclose such information to third parties, including but not limited to agents, contractors, service providers, offer suppliers. The Promoter will not otherwise disclose your personal information unless you have been informed or you have consented or the Promoter is otherwise permitted or authorised to do so by law. Participation in the Promotion is conditional on providing this information. The Promoter may, for an indefinite period, unless otherwise advised, use the information for promotional, marketing, publicity, research and profiling purposes, including sending electronic messages or telephoning the claimant. Claimants should direct any request to access, update or correct information to the Promoter. All claims become the property of the Promoter. The Promoter's privacy policy can be found at **www.bosch-home.com.au** (follow the 'Privacy' link). **8. BSH employees:** The Promotion is not open to employees of the Promoter and their immediate families (or their associated agencies) unless the Eligible Products are purchased from a Bosch authorised reseller in Australia in accordance with these Conditions. **9. Verification:** The Promoter reserves the right, at any time, to verify the validity of claims and claimants (including a claimant's identity, age and place of residence) and to disqualify any claimant who submits a claim that is not in accordance with these Conditions or who tampers with the claiming process. Errors and omissions will be accepted at the Promoter's discretion. Any misrepresentation or fraudulent information supplied by a claimant disqualifies their claim(s). Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights. **10. Discretion:** The Promoter's decision on all matters pertaining to this Promotion is final and binding and no correspondence will be entered into, except as otherwise stated in these Conditions. **11. Transferability:** Claims are not transferable or assignable. **12. Implied Guarantees:** Nothing in these Conditions limits, excludes or modifies or purports to limit, exclude or modify the statutory consumer guarantees as provided under the Competition and Consumer Act 2010 (Cth), as well as any other non-excludable warranties under applicable consumer protection laws in the relevant States and Territories of Australia where a purchase is made (**Non-Excludable Guarantees**). Except for any liability that cannot by law be excluded, including the Non-Excludable Guarantees, the Promoter (including its respective officers, employees and agents) excludes all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of a claimant's participation in the Promotion. **13. Liability:** Except for any liability that cannot by law be excluded, including the Non-Excludable Guarantees, the Promoter (including its officers, employees and agents) is not responsible for and excludes all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of: **(a)** any technical difficulties or equipment malfunction (whether or not under the Promoter's control); **(b)** any theft, unauthorised access or third party interference; **(c)** any claim that is late, lost, altered, damaged or misdirected (whether or not after their receipt by the Promoter) due to any reason beyond the reasonable control of the Promoter; **(d)** any variation in a bonus to that stated in these Conditions; or **(e)** any tax liability incurred by a claimant. **14. Modifications:** If this Promotion is interfered with in any way or is not capable of being conducted as reasonably anticipated due to any reason beyond the reasonable control of the Promoter, including but not limited to technical difficulties, unauthorised intervention or fraud, the Promoter reserves the right, in its sole discretion, to the fullest extent permitted by law: **(a)** to disqualify any claimant; or **(b)** to modify, suspend, terminate or cancel the Promotion, as appropriate. **15. Laws:** These Conditions will be governed by and construed in accordance with the laws in force in Victoria, Australia.
