Bonus** means a Bosch PRA MultiPower Radio 06039A9040 valued at \$99 RRP. **Eligible Product** means a current Bosch home appliance listed on the Bosch Home Appliances website [www.bosch-home.com.au](http://www.bosch-home.com.au). **Promoter** means BSH Home Appliances Pty Ltd (ABN 22 109 198 405) of 1555 Centre Road, Clayton, VIC 3168. **Promotion Period** means the period commencing 9 November 2017 until such time as the Promoter has achieved the number of Winning Claimants. **Winning Claimants** means the first 100 valid and unique claimants to review an Eligible Product during the Promotion Period and comply with the Conditions, in particular completion of the online form referred to below that are received, processed and accepted by the Promoter from the commencement of the Promotion Period. **4. Required details:** In order to obtain the Bonus, the online review form must be completed in full as specified including providing the claimant's name and e-mail address. **8. Errors and omissions will be accepted at the Promoter's discretion. Any misrepresentation or fraudulent information supplied by a claimant disqualifies their claim(s). Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.

**11. Discretion:** The Promoter's decision on all matters pertaining to the Promotion is final and binding and no correspondence will be entered into, except as otherwise stated in these Conditions (if at all).

**12.** Subject to Condition 13, the Promoter, its directors, employees, agents and contractors, and the agencies and companies associated with this Promotion (**Associated Entities**) will not be liable for any loss (including, without limitation, indirect, special or consequential loss or loss of profits), expense, damage, personal injury or death which is suffered or sustained (whether or not arising from any person's negligence) by any person, arising out of or in connection with this Promotion, except for any liability which cannot be excluded by law (in which case that liability is limited to the minimum allowable by law).

**13. Implied Guarantees:** Nothing in these Conditions limits, excludes or modifies or purports to limit, exclude or modify the statutory consumer guarantees as provided under the Competition and Consumer Act 2010 (Cth), as well as any other non-excludable warranties under applicable consumer protection laws in the relevant States and Territories of Australia where a purchase is made (**Non-Excludable Guarantees**).

**14. Liability:** Except for any liability that cannot by law be excluded, including the Non-Excludable Guarantees, the Promoter (including its officers, employees and agents) is not responsible for and excludes all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of: **(a)** any technical difficulties or equipment malfunction (whether or not under the Promoter's control); **(b)** any theft, unauthorised access or third party interference; **(c)** any claim that is late, lost, altered, damaged or misdirected (whether or not after their receipt by the Promoter) due to any reason beyond the reasonable control of the Promoter; **(d)** any variation in a bonus to that stated in these Conditions; or **(e)** any tax liability incurred by a claimant.

**15. Transferability:** Claims and the Bonus are not transferable, assignable or exchangeable.

**16. **19.** A term (or part or parts thereof) of these Conditions will not apply where the term is unenforceable under the law of the relevant jurisdiction under which any legal action is legitimately taken, however such terms (or part or parts thereof) are severable and do not invalidate the remaining terms.
