## **Bosch Product Review Promotion - Conditions of Entry**

## Valid 1 June 2020 – 31 May 2021.

This section sets out the Conditions for the Bosch Product Review Promotion and details how you can enter the draw to win a Bosch Athlet Cordless Vacuum Cleaner BCH6255NAU.

- 1. Definitions: *Eligible Entrant* means New Zealand residents with a residential address in New Zealand, aged 18 years or over, who have purchased an Eligible Product (as defined below). *Eligible Product* means any Bosch home appliance product purchased from an authorised New Zealand reseller that is listed on the Bosch Home Appliance website (<a href="www.bosch-home.co.nz">www.bosch-home.co.nz</a>). *Prize* means a Bosch Athlet Cordless Vacuum Cleaner BCH6255NAU valued at RRP NZD\$529.00. *Promoter* means BSH Home Appliances Ltd (NZBN: 9429035347989) of Level 3, Air New Zealand Building, Smales Farm, 74 Taharoto Rd, Takapuna, Auckland 0622. *Promotional Period* means the period commencing 1 June 2020 and close of business on 31 May 2021 (inclusive).
- 2. Participation: Participation in this Promotion constitutes acceptance of these Conditions.
- **3. BSH employees:** Employees (and their immediate families) of the Promoter and agencies associated with this Promotion are ineligible to enter. Immediate family means any of the following: spouse, exspouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or first cousin.
- **4. - **14. Discretion:** The Promoter's decision on all matters pertaining to the Promotion is final and binding and no correspondence will be entered into, except as otherwise stated in these Conditions (if at all).
