The 2024 Bosch® Product Registration Sweepstakes (the “Sweepstakes”) is sponsored by BSH Home Appliances Corporation, 1901 Main Street, Suite 600, Irvine CA 92614 (“Sponsor”).

**1. BRIEF OVERVIEW OF The 2024 Bosch® Product Registration Sweepstakes:** The Sweepstakes commences on May 15, 2024 on/about 6:00:00 AM Pacific Time and ends on December 31, 2024 at 7:59:59 PM Pacific Time (the “Sweepstakes Period”). The Sweepstakes consists of two (2) Periodic Prize Drawings. Each individual Periodic Prize Drawing has the Start Date and End Date as set forth in the table below.

The computer of the Sponsor shall be deemed to be the official Sweepstakes Period clock for each Prize Period.

**2. ELIGIBILITY:** This Sweepstakes is open only to legal United States residents in the 50 United States and District of Columbia, 18 years of age or older, established at the time of entry. Employees of Sponsor, and its respective parent company, affiliates, subsidiaries, advertising, promotion and production agencies, and their immediate family members (i.e., spouse, parent, child, sibling, and the “steps” of each) and persons living in the same household of each (collectively, “Sponsor and Others”) are not eligible to enter. All federal, state and local laws and regulations apply. Void in Puerto Rico, the United States Territories and Possessions, and elsewhere where prohibited or restricted by law. Participation constitutes Entrant’s full and unconditional agreement to these Official Rules and Sponsor’s decisions, which are final and binding in all matters related to this Sweepstakes. **3. HOW TO ENTER THE SWEEPSTAKES:** An Entrant must register a Bosch appliance between May 15, 2024 and August 15, 2024, or October 1, 2024 and November 30, 2024. Entrant must register their Bosch appliance on the Bosch Home Appliances website at <https://www.bosch-home.com/us/mybosch/registration> , by the mail-in registration card or by the photo-registration process..

Entrant may register as many appliances as they own.

Entrant may not enter using multiple email addresses.

Entries must be received by the end date of each period. Only one (1) entry per Sweepstakes Period allowed.

**4. DRAWING:** On the Random Drawing Date for each respective Sweepstakes Period, (as shown on the table in Section 1), Sponsor will randomly draw one (1) potential Prize Drawing winner from the eligible entries collectively received from the Bosch Home Appliances U.S. website, mail-in registration, photo-registration, and from those entries captured via the sweepstakes form on the Bosch Home Appliances U.S. website during that respective Sweepstakes Period. Each Prize Drawing will be from a pool of all eligible entries submitted during that Sweepstakes Period. Non-winning entries from one Sweepstakes Prize Drawing will not carry forward to subsequent Sweepstakes Prize Drawings.

**5. PRIZES, APPROXIMATE RETAIL VALUE (“ARV”) AND ODDS OF WINNING:**

**A. Prizes (2):** The Prize is a \$1000 Williams Sonoma gift card. A maximum of two (2) Prize are available to be won. Approximate Retail Value (“ARV”) of each Periodic Prize is \$1000.00. Limit one (1) Prize per household.

**B. Odds of Winning:** The odds of winning a Prize depend on the total number of eligible entries received via the Bosch website, mail-in registration card, photo-registration process, and sweepstakes form. One (1) winner for each Sweepstakes Period will be selected from the eligible entries collectively received from Bosch website, mail-in registration card, photo-registration process, and sweepstakes form.

**C. Approximate Total Retail Value of all prizes is USD \$2000.00.**
